## The Vancouver Masonic Center

Brethren of Mt Hood Lodge #32,

With the theft of funds emptying the investment accounts of the Temple Board which were utilized to provide operating cost cash flow, we have been operating our building at a deficit which cannot be continued long term without bankrupting the tenant lodges. While we do not need to have a fire sale, we need to sell the building. As most of you know, the Vancouver Masonic Center is now listed for sale for \$1.9 Million dollars.

Sunday 10/19/14, the President of the Vancouver Masonic Temple, Inc. (VMTI), Brother Dean Roettger, called for a meeting of Trustees. The purpose of the meeting was to respond to a solid offer to our building which required an answer within five days. In attendance representing Mt Hood Lodge #32 were WB James Wing and myself; I carried a proxy and direction for his vote for our SW Jason Masuoka who was not able to get out of work. Our WM Steven Thompson was there as a representative of York Rite. We had a quorum and just enough stock shares represented to take a vote regarding sale of the building. After much debate, we had the required unanimous vote to make a counter offer.

Your Temple Board Trustees are Temple Board Vice President VWB Dave Daily, WB James Wing, SW Jason Masuoka and I, WB John Laws. I have asked the WM for some time at our November 13<sup>th</sup> Stated Meeting for your Trustees to present possible courses of action and receive input on the will of the brethren to guide our votes going forward.

There are some important decisions to be made that will affect us all in the near and long term. If you are interested in the future of our lodge, it will be an important meeting to attend! It is the sad end of one chapter for our lodge but the exciting beginning of another!

Greetings Brethren!


